- **Make sure all information is complete. Include check along with application. Any application not completed is not considered. Locations are assigned on a first paid, first come basis and are placed at the discretion of the Summer Festival Committee.**

Vendors will not hold the Festival participants, directors, volunteers, or employees responsible for claims, losses, fees, damages, or expense. The Festival will not refund due to inclement weather, government action, strikes, or other matters beyond its control.
