Include check along with application or call with credit card. Incomplete applications will not be considered. 3. Provide a clear and accurate description of your products on the application, or an additional page or photos if necessary. Vendors are not allowed to sell t-shirts, silly string, pop rocks and toy guns/knives. 4. If you sell unapproved food items, you may be asked to leave. 5. The Summer Festival cannot guarantee that other vendors will not duplicate your type of craft or items. 6. Absolutely no refunds. 7. Non-profits must describe information/service you will be offering and/or items to be raffled. 8. Vendors are required to set up on Friday, June 10th. 9. Security will be provided Friday night; however, you are still responsible for items left at your booth. 10. All vendors must clean the area around their booth space(s) before they leave at the end of the day. 11. No generators will be allowed. 12. The Summer Festival Committee reserves the right to remove any vendor from the Festival if it feels the vendor is in violation of the rules and regulations or the spirit of the Festival. **BOOTH FEES WILL NOT BE REFUNDED IF A VENDOR IS CONSIDERED TO BE IN VIOLATION OF THE RULES.**
