 Non-profits must describe information/service you will be offering and/or items to be raffled.
 Vendors are required to set up on Friday, June 7th.
 Security will be provided Friday night; however, you are still responsible for items left at your booth.
 All vendors must clean the area around their booth space(s) before they leave at the end of the day.
 No generators will be allowed.
